

# Guracha ilogally, court told

A WOMAN claiming inheritance of over Sh50 million worth of property of Moyale MP Guracha Galgalo, left her husband immediately he issued Talak, according to the Islamic law on marriages and divorce, a court heard yesterday.

The court heard that Rehema did not wait for the customary three months to end before leaving her husband.

She later filed a divorce petition in the High Court and attached a marriage certificate from the assistant registrar of marriages in Sheria House.

But efforts by Rehema's lawyer Mr Cecil Miller to produce the affidavit and a copy of a marriage certificate to the court as exhibits were heavily contested by Mr Alfred Nyandieka, acting for Galgalo's first wife, Bernana, saying they were

But Miller told the court that it was disrespectful for Mr Nyandieka to claim that an advocate with the High Court of Kenya could produce forged documents in court.

Justice Daudi Onyancha set a ruling to determine whether the documents being used to prove Rehema's case would be accepted or rejected by the court.

# Guracha wife acted CIVIL SERVICE PAY RISE IS BEING WORKED

THE Government is expected to announce the newly revised salaries for civil servants by the end of this month.

The new salaries aimed at narrowing the gap between the lowest paid Government worker and their highest paid counterparts has been awaited eagerly following the promise by minister in charge of Public Service, Moses Aka-

minister announced on Tuesday that the revised salaries for employees in job groups A-L and M-N would be announced once other modalities were concluded.

Targeted to benefit are civil servants in job groups J, K, L, M and N. A majority of them are diploma and degree holders who have acquired vast experience in handling administrative and technical duties. Presently they earn between Sh18,000 to Sh30,000.

Those below these grades are basically auxiliary staff ranging from job groups A upwards. They include clerical officers, secretaries, drivers and office messengers who back up the operations done by the professional, techni-cal and administrative staff. They earn about Sh7,000 to Sh9,000 per month and it is expected that the revised scheme will see them earn a

little more. The minister revealed this as he addressed senior managers in the public service taking a senior management course at the Kenya Institute of Administration in Nairobi.

He said employees groups M and N, who include the middle level officers, would also see their salaries revised to narrow the gap the difference with those in job groups P.

Currently, employees in groups M and N earn about Sh40,000 whereas those in group P earn about \$5,70,000. Group P consists of government managers like the under-secretaries in ministries and district commissioners.


However, Mr Akaranga said those earning above job group P will not benefit from the revised salaries.

At the same time, Mr Akaranga announced that the government will from next year introduce very tough performance contracts police officers. He said the approach would be one way of addressing insecurity in the country.

The minister wondered how insecurity could rise in the country, with the current strong network of the provincial administration and police formations.

He announced that last year's performance indices for each ministry will be released in October this year and warned permanent secretaries whose ministries would have performed below par that they risked being

sacked. The last time civil service salaries were increased was in August 2005 when then Public Service Minister William Ntimama announced a 14 per cent, on average, pay rise to avert a threat-



#### Pakistani found without papers

CITY COURT: A Pakistani national was yesterday charged in court with being in the country illegally. ## Group wants shoot order withdrawn

A LOBBY group has called for the withdrawal of the shoot to kill orders issued by internal minister John Michuki earlier this year in the crackdown on crime and further demanded the sacking of policemen they claimed

had been implicated in extra-

judicial killings. Release of Political Prisoners (RPP) accused the police of being behind the recent killings of five men whose bodies were found in the bush near a shooting range in Athi River.

RPP executive coordina-

tor Stephen Musau yesterday took the force to task and said: "The police are the ones responsible in the Kitengela killings and dumping of the dead bodies."

But as the RPP went public with their view of the unexplained deaths, police commissioner Major-General Hussein Ali released a statement defending the force.

We are carrying out our own investigations into the killings. ... and so far, we have findings that we don't wish to disclose at this point because doing so will preju-dice our case," Maj-Gen Ali

In a broader report they released yesterday, RPP revisited the police operation in Mathare Valley as they tracked down members of the outlawed Mungiki sect and said too much force had been used. They also mentioned recent incidents of people who had disappeared.
