Galgalo widows fight over Sh50m estate

A MARRIAGE certificate obtained by a woman seeking the control of over the Sh50 million estate of the late Moyale Member of Parliament, Dr Guracha Galgalo was fraudulently obtained, three lawyers told the court yesterday.

Lawyers Cecin Miller, Alfred Nyandieka and Sheba Mohammed confirmed to Justice Onyancha that a marriage certificate secured by Rehema Dida Jaldesa and Major (rtd) Abdinoor

ha Jillo was fraudulently of a ned from the Registrar of Marriages at the Attorney General Chambers on September 16, 1993.

All the lawyers are appearing in a case pitting the two women Rehema and Bernadetta Okotu Shama. Rehema is opposed to Bernadetta being given control of the estate of the deceased

who perished in the Marsabit plane crash last year.

Mohammed had been called to testify in favour of Rehema since he handled a divorce case between her and Jillo.

Mohammed told the judge that Jillo disclosed to him that he used under hand is deals to secure the marriage certificate between him and Rehema for official use in their places of work.

The lawyer told the judge that Jillo said an official document was needed at the Kenya Commercial Bank (KCB) where Jaldesa was working to be awarded medical cover as she was expectant.

The military officer further divulged to the witness that he needed the certificate to enable his then wife to access facilities at the Department of Defence (DoD). Rehema claims she divorced Jillo through Talak and later got married to Dr Galgalo under Islamic rites.

The late MP married Bernadetta in a Christian wedding ceremony officiated by a Catholic Priest in Isiolo 1993 and they had been blessed with three siblings.

When Galgalo died, Bernadetta obtained letters of administration over his estate but Rehema has raised an objection saying she should alsdo be included as an administrator of the vast estate of the deceased.

Hearing of the case proceeds November 28.

Court seeks prosecution advice on politician's case

A NAIROBI court yesterday ordered the prosecution in a criminal case facing politician John Ngenga Kamau of Kipitri constituency to advise the court on the position of the accused's application to halt the trial.

Trial Magistrate Teresia Ngugi directed that she be appraised with the advice before the hearing of the criminal case on December 19.

The accused, who is a motor vehicle dealer faces several criminal cases filed by people he allegedly received monies from by pretending he was in a position to import for them motor vehicles from Japan.

otor vehicles from Japan. Yesterday when the case came up for mention, the trial sought to be informed of the decision made by the superior court, in which the accused claimed to have been issued with orders stopping all criminals cases pending before a magistrate's court.

However the order of the High Court made available indicates that police were barred from searching his offices and confiscating computers and other tools of trade from his Nairobi office.

The accused is charged that on diverse dates between October 2005 and 2006 at Anniversary Towers jointly with others not before the court with intent to defraud, obtained Sh1.5 million from Patrick

Wanjohi by pretending that he was in a position to import for him a motor vehicle make Toyota Coaster minibus from Japan, a fact he knew to be untrue.

The constituents of Kipipiri over the weekend nominated Ruth N. Njoroge (ODM) while Finance Minister Kimunya got PNU nomination. The accused's name was missing from the list of names made available to the press.

The suspect was nabbed by the police on June 2007 after the complainant lodged his case and was later arraigned in court charged with obtaining money by false pretence contrary to section 313 of the Penal Code.
