# KQ hostess conned me of Sh0.2m, officer testifies

A KIBERA court yesterday heard how a Kenya Airways air hostess stole Sh200,000 from a police officer.

Constable Lawrence Nyingi Gikonyo attached to Buru Buru police division told Resident Magistrate Mary Mwai that the money was meant to purchase a Nissan matatu for him from Dubai.

He was testifying in a case in which Susan Wambui, an air hostess and Jean Wanjuki, a businesswoman, have denied stealing the money which had been entrusted to them by the officer to allegedly buy him a vehicle.

They are said to have commit-

ted the offence on July 21, 1997 in Nairobi.

The accused are represented by lawyer C. Miller while the prosecution is led by Inspector Stephen Wambua.

Gikonyo said he was told to wait for a month to get the vehicle but it was never delivered. After one year, he became suspicious and reported the matter to the police. The hearing continues.

Meanwhile, the High Court yesterday reduced to 10 days imprisonment the sentence imposed on two teachers found guilty of dangerously

hanging on a matatu.

Nairobi Judge, Samuel Oguk, ordered the immediate release of Jairus Ombima and Obedi Sylvanus. The two were on April 9 jailed for two months each by a Migori magistrate.

Revising the jail-term imposed on the two teachers, Oguk said the end of justice in the cases would have been served best through the imposition of a non-custodial sentence such as a fine.

He said the teachers had sufficiently been punished for the offence which did not deserve the imposition of a custodial sentence.

## Three charged over Sh0.6m theft

THREE people were yesterday charged with stealing building materials worth Sh617,800.

Peter Murage, 27, Peter Ndivo, 65 and James Murige, 55, appeared before a Makadara court accused of stealing the materials between last April 7 and 11.
